



- A. The President of this Trust has been appointed on behalf of this Trust for supervision of Full-Time Workers. Whereas, all of us were paid sum of Rs. 10,000.00/- as a Share-Capital to this Trust.
- B. The President of this Trust Mr. S.P. Ramar has been appointed as an Honorary Auditor to maintain and managing the all Trust Monies and of all income and investments and all outgoing expenses.
- C. One of the Executive Committee Member shall be appointed for administrating and for advisory of this Trust.
- D. The Members of the Trust shall be working for the Sri Saraswathi Vidhyalaya Educational Trust.
- E. The person who desirous to become a Member of this Trust shall be appointed with consent of the 2/3 majority members of this Trust.
- F. The person who desirous to become a Member of this Trust may be paid the Registration Fees of sum of Rs. 1000.00 and also be paid sum of Rs. 100/- monthly as a subscription, will become the same.
- G. The person who acts contradicts to the objectives of this Trust shall be removed through resolution made by the 2/3 majority members.
- H. Each members of this Trust shall have a voting right to vote whenever they present in the meeting. In respect of any kind of administration, if 5 or more members of Administrative Committee or President of the Board decides then they have to create Secret Voting System. In case, the Vote is a tied one, the President of Board apart from his single Vote, he may decide as either 2 in 1 ( Casting Vote ).

The Annual year of this Trust shall be calculated from the 1<sup>st</sup> day of April of year and it ends on 31<sup>st</sup> day of March of Next upcoming year.

#### **8. Administrative Committee:**

- A. The Trust Administrative Committee has the following persons one President from the Directors, One Vice- President, One Secretary, One Vice- Secretary, One Treasurer, One Vice- Treasurer, 9 Directors, all these aforesaid 15 designation alone be in the administrative committee.
- B. During the interval of posting of Administrative Committee, it itself may fill the post based on the resolution of voting of 2/3 Majorities.
- C. Administrative members are elected within 3 years at once by the members of General Body members at the time conducting the General Body Meetings.
- D. The Administrative Members shall be tenure for 3 years from the date they elected for. After completion of tenure, the Administrative Members are eligible for all post thereafter to. List of Roll of Administrative Members will be volume to the record-registrar of the

E. Prior Notice for a period of 7 days has to be circulated before the date of conductance of the Administrative Committee Meeting. The Administrative Members who not participates in the three consecutive Administrative Committee Meetings then he shall not eligible for the post of the Administrative Committee Members.

**9. Functions of Administrative Committee Members :**

- The President - must be conducting all general administration and must be presiding person to conducting the Trust Committee's Meetings of the Sri Saraswathi Vidhyalaya Educational Trust.
- The Vice- President - Incase, the President is defaulted to conduct presiding of anything then the Vice-President should be conducted as the responsibility of the President.
- The Secretary - has to look after the all savings & Expenditure of this Trust and to look after the Court Cases.
- The Vice-Secretary - need to assist/ help the neediness of the Secretary in their works.

The Vice- Treasurer - need to assist/ help the neediness of the Treasurer in their works.

**Members of the Administrative Committee :**

The Treasurer and the Vice- Treasure may receive the amount from the bank for the Trust expenses. The Secretary is having right to spent an amount of Rs. 10,000/- for any month for purpose of objectives of this Trust without getting any permission from the Administrative Committee. In case any huge amount was spent as an expense, then the Secretary has to get permission from next Administrative Committee Meeting. At any dates, the Treasurer is allowed to kept himself an amount of Rs. 10,000/- for the Trust Expenses. Incase, amount is higher than Rs.10,000/- the Treasurer and the Vice- Treasure have to be signed for deposit and withdraw from the bank as the resolution made by the Administrative Committee in respect of the amount.

**10. General Body Meeting :**

The General Body Meeting has to be conducted at once in year on or before 30<sup>th</sup> June. The Prior Notice in written letter has to be given to all the members before 21 days from the date of forming the General Body Meeting. The aforesaid notice has to be even affixed in the Notice Board of the Trust.

The Quorum of Meeting of the Trust shall be 2/3 Share members. In the General body meeting, the Election of the members of Administrative Committee, Trust savings and expenditure accounts, 5<sup>th</sup> amount account notice signed by the Auditor has to be presented, aforesaid savings and expenditures shall be agreed by the 2/3 majority of the members of the Trust and approved the same as so.

**11. Special General Body Meeting:**

At anytime through written application, if requires, the Administrative Committee Members may conduct the Special body meeting. After getting approval for conducting the Special General Body Meeting and same has to be conducted within 1 month from the date of approval. By agreeing the suggestion of the 2/3 Members, the members who are desired to conduct the Special General Body Meeting may conduct the same as themselves.

**12. Rolls of Members/ Register of Members :**

The members of the Trust particulars like their names, address, occupation etc., has to be properly maintained as a record of Rolls of Members/ Registrar of Members and the members name may either add or remove from the Register accordingly at respective period of time.

If any member act contradict to the rules and regulations of this Trust, then the respective Committee is authorized to warn the member and may charge penalty of Rs. 100/- for commit of breach of rule.

**13. Meeting Minutes Book:**

All the happenings and events conducted and participated in the Administrative committee Meeting and the General Body Meetings has to be recorded all the particulars in this Meeting Minutes Book and same has to be signed by the presiding members of the each respective committee.

#### **14. Accounts Records has to kept in the Trust**

Book related to Cash Receipts, Vouchers, Documents related to joint and separate credit of the Members, debt records, Monthly record related to disbursement of Credit, these all records have to be kept in the Trust.

When at the time of opening bank account in the name of Trust and at the time of any amount transaction through cheque then both the Treasurer and Vice-Treasurer have to be jointly signed for it.

#### **Notice of Credit and Debt.**

After the completion of the each Financial Year of the Trust, the assessment made as the debt and credit and 5<sup>th</sup> amount account has to be sent for appointed Auditor after his auditing same to be presented for approval before the General Body Meeting and same should be approved.

Within 1 month from the date of conductance of General Body Meeting, declaration deed has to be prepared with regard to authorized Trust Saving and Expenditures accounts, 5<sup>th</sup> amount account and Notice, Rolls of Members list, Trust running particulars in the every end of the Financial Year.

#### **Finance of the Trust**

The Trust Finance may be obtained for the betterment of Trust by way of gifts, subscription and Government subsidy.

The President, The Secretary and The Treasurer are liable and responsible for the all kinds of funds of credit in Trust obtained. Whereas, for the proper account maintenance of credit, The President, The Secretary and The Treasurer are liable and responsible to render the receipts too.

The Funds of Trust may be kept in the bank through the advice of Administrative Committee and if it requires for development of Trust, as per the guidance of Administrative Committee funds of Trust may be invested.

No amount of funds of Trust shall be given to any members of the Trust as bonus or like other. All funds of Trust shall be only used for development and betterment of the Trust alone.

#### **Objectives and System of Rectification of Rules:**

The General Body has power to rectify the Rules and Objectives of the Trust. The resolution made by the General Body with respect to any kind of rectification, the same has to be executed only through either voting or attend members via proxy of 2/3 Majority. After the execution of resolution made by the General Body, the same has to be presented before the President and the Vice- President.

Incase, if it requires change of place of Trust for the comfort functioning of Administrative Committee or to be decided the same from at present business place, then the same has to be changed as per the resolution made by the Administrative Committee.

For the betterment of Education, as per guidance given by the Administrative Committee, loan amount may be obtained only from the suggested bank or private entity and in the same way the property has to be purchased and construction of building also. All these powers are rendered to the Trust's President, Vice-President, Secretary, Vice- Secretary, Treasurer, Vice- Treasurer.
